

#### **JANUARY RECAP**

At January's LC, our topic was **tele-sexual health.** The COVID-19 pandemic forced clinics to get creative in how they delivered services. While it might have started as something clinics had to do, many clinics decided to continue offering telehealth services. At the LC, Caroline Carnevale, DNP, MPH, AAHIVS, shared tips and tricks for offering remote STI testing and treatment (including presumptive treatment and EPT), PrEP care, and HIV testing. #### **ASK A CLINICIAN**

<u>Question:</u> "Regarding the recently updated CDC PrEP Guidelines - HIV testing for both oral and injectable PrEP now includes both antigen/ antibody test and viral load testing. In my practice, if we had to routinely check viral loads for all patients before starting PrEP and during routine monitoring, that would limit our ability to offer PrEP. We're a student health center and would either have to send patients to an outside lab so their insurance can be billed (we don't bill insurance or the patient for our in-house labs) or refer out for PrEP management. Is the viral load optional?"

<u>Answer</u>: "Yes, you are correct that the CDC has now recommended HIV viral load testing in addition to antibody/antigen tests for every visit while a person is taking PrEP (both tablet and injectable). While this is the recommendation, this may not be feasible in some clinical settings. Due to cost and logistical issues, many sites are not offering viral loads routinely or are only performing viral loads on select patients based on clinical judgement. While offering an HIV viral load is optimal, not being able to offer everyone a viral load should not discourage you from offering PrEP in your clinic."
